The Intercultural Awareness Team Neukölln (IKAT) is a model project, financed by the Neukölln District Office.

Dear Sir or Madam, dear Neukölln residents,

Since November 24th **the 3G** regulation applies to **public transport and at work** throughout Germany. We have summarized the new regulation for you and translated it into seven languages (English, French, Arabic, Farsi, Polish, Turkish, Romanian).

3G regulation in local public transport

Since November 24th, full vaccination or recovery from COVID is mandatory for usage of public transport.. Both proofs can be shown either via the yellow vaccination book, the digital certificate in the Corona-Warn-App and / or CovPass or a printed QR code.

Anyone who has <u>not been vaccinated</u> or <u>recovered</u> must carry a <u>negative test report, renewed</u> <u>daily.</u>

3G regulation at work

Access to the workplace is also subject to the 3G regulation. This means that employers and employees only get access if they are fully vaccinated, tested negative or recovered. Corresponding evidence must be at-hand for the employer.

Important note: Self-tests are not permitted. PCR tests are valid for 48 hours.

Companies are obliged to offer antigen tests (PoC tests) to all colleagues in the workplace twice a week. This can also be done via self-testing-kits. Please note that PoC rapid tests are not valid for more than a maximum of 24 hours. Employers are also obliged to monitor and document compliance with the 3G condition.

Mobile working and home office

Employers are obliged to enable their team to work from home or mobile by arrangement.

Employees are obliged to accept the offer and work from home. Office workplaces should only be occupied up to a maximum of 50 percent.
